The third every-other-year reunion of the Old Lacey School will be held Sunday afternoon, August 15, 1993 in Heritage Hall, Thurston County Fairgrounds, from 1:00 until 4:00 p.m.

May 1-2, 1993: The Lacey Fun Fair held at St. Martins Capital Pavilion. In addition to an information Table the Society had demonstrations of making old time butter, ice cream, and apple cider.

June 27, 1993: The Lacey Historical Society held it's annual Founders Day remembrance at the Lacey Museum. A display at the museum included photos and memorabilia of Lacey past, and guests were taken on tour of some of the old Lacey homes.

House Sale Brings Profit

The LHS House Project started with a gift of a house by Ruth and John Lewis, located on the new Albertson's store property. It had to be moved. The Society arranged with Olympia Federal Savings & Loan Association for a construction loan, then had Rainier Movers move the house to a lot secured with the help of John Puckett, on Mesplay St. SE.

The Society had a septic system installed, plumbing work done, new roof, new paint, a lot of grading and concrete work was sub-contracted, and donations were made by many generous construction companies.

The house committee members: Tom Huntamer, Dick Husk, Denise Keegan, and John Puckett, spent many long hours at the house, as did other members of the Society. The sale of the house has just been completed and the Society ended up with a substantial margin over costs which will be used for improvements on Society properties.



Pioneer Cemeteries Committee Report

Historic Ruddell Pioneer Cemetery Association elected prominent Lacey businessman Robert Kasgy, owner of ABC Printers, President. Other officers and trustees also elected by 35 pioneer family members attending this 79th Anniversary meeting June 13, 1993 were: Rodger Easton, Vice President; Mina Bowker, Secretary Treasurer; Judy Hildebrandt, Assistant Secretary; Lyman Fleetwood, trustee 3 year; Robert Mayes, Trustee 2 year; and Robert Southwick, Trustee 1 year.

This Historic "Cemetery within a Cemetery" dates back to 1852 with land donated by Stephen Ruddell and the James Southwick families.

The Ruddell Pioneer Cemetery Association was incorporated June 22, 1914 for the purpose to acquire, own, improve, beautify and manage the cemetery and was dedicated to pay tribute honoring the early pioneer family members burried there. The incorporators and first elected trustees and officers were, Del Kagy, President; W.W. Fleetwood, Vicepresident; Gwin Hicks, Secretary; G. A. Stedman, Treasurer; and W. S. Shaser, Trustee. History repeats—grandsons following leadership of grandfathers.
